General Action Steps for Producers to Process in Existing Licensed Kitchens

1. Determine which products will be processed, if they are shelf-stable, and where they will be sold – who will be the intended customer.
2. Write out the step-by-step process for each product.
3. Talk with Department of Inspections and Appeals to determine which licenses will be required and what other requirements there are.
4. Complete required and/or desired food safety training.
5. Seek out a kitchen to work with. Consider which products are being processed, as well as licensing of the kitchen and equipment, refrigeration, freezer space, and dry storage available for your use.
6. Check with insurance agent about insurance needs with processing and product storage (if applicable).
7. Develop a rental agreement for use between the kitchen and the producer and have your lawyer review the document.
8. Department of Inspections and Appeals reviews recipes, food safety procedures to be followed during processing, and all other requirements.
9. Develop a promotional piece for your value-added processing products, and market your new business.
10. Implement processing on a limited basis at first and expand as appropriate.
